# What we use your information for

- To trusted third parties who perform functions on our behalf and who also provide services to us, such as professional advisors, IT consultants carrying out testing and development work on our business technology systems, research and mailing houses. These third parties comply with similar undertakings of privacy and confidentiality as Premier Placement Services Limited.
- The personal and sensitive personal information you provide us may be sent to clients and third parties located outside the European Economic Area (EEA). When we transfer your personal information outside the EEA we will take reasonable steps with the aim of ensuring that your privacy rights continue to be protected.

# How long do we keep your information for?

We will only retain your data for as long as there is either a statutory requirement or legitimate obligation for us to do so or to be able to provide a service to you. This will usually require us to retain your personal data after any business relationship has ended for accounts and records purposes and to deal with any account support questions. This is usually for a two year period from the last date of data being processed, however it can be up to 8 years if there is a legal obligation to retain data for longer than two years.
